#### **Committee Reports**

**Committee of the Whole -** All Board committees, with the exception of the curriculum committee, combined to meet as one committee for the month of January. Board members Indicated a desire to continue that format.

**Curriculum Committee -** A presentation was given by the Music Department, followed by a discussion regarding the district's music curriculum.

**Administrative Reports -** Brian Sutton addressed the Badger Exam and ACT test results and recognized some of the efforts that are in place to increase student test scores throughout the district.

Treasurer's Report - Bob Chady reviewed a newly formatted monthly revenue and expense report.

**Legislative Report** - Jon Bunch reported on State of the State Address. He discussed the plan to reduce health benefits for State employees and earmark that savings for public education, as well as plans to place more dual credit classes into schools.

#### Presentation by McKinstry regarding progress on the Act 32 projects throughout the district

Representatives from McKinstry presented information on the status of the energy project work that has been completed, work that is in progress, and previewed work that will be done in the next six months. McKinstry also discussed the measurement and verification of the associated guaranteed energy cost savings and the reporting requirement of that savings to the district and the DPI. No action sought

## Presentation regarding Academic and Career Planning

Tracy Lipinski, Elementary and Middle School Counselor, presented plans in place to implement Academic and Career Planning at the elementary school and middle school. The DPI has adopted *Career Cruising* as the online tool for Wisconsin schools to use in implementation of *Academic and Career Planning* by 2017. No action sought.
