#### A. Education Quality & Culture

i. WI Act 266: 118.01 (2)(c)8 Updates

Went into effect in April, 2024.

Dr. Bartels presented on where do we currently teach about WI Act 266 and senate bill 240.

118.01(2)(c) 8. At all grade levels, and understanding of human relations, particularly with regard to American Indians, Black Americans, Hispanics, Hmong Americans, and Asian Americans.(Wisconsin Legislature: 118.01) Handout provided to the board describing each building lesson plans, and integration. Questions about MS/HS content/representation.

ii. Jostens Renaissance Global Conference Updates

Presentation with Ms. Young and some of the Cardinal Crew students. They shared a visual presentation recapping the Orlando conference, their experiences there and some of the things they have done so far this year to pass along those leadership skills and excitement to our buildings. Marshall HS was recognized as a Platinum School of Distinction. Less than 1% of schools in Jostens Renaissance Program are recognized with this distinction. They are excited to keep growing this culture in Marshall.
