- 3) Face coverings are recommended, for after school spectators, while indoors through January 21.
- 4). All students and staff will be required to wear a face covering while riding district transportation.
- 5). The Board of Education will discuss face covering expectations at the Regular meeting each month (3rd Wednesday).
