Motion Carried 5-1.

Discussion and potential action to approve and adopt Defeasance Resolution- Motion by Wehking and seconded by Herschleb to approve and adopt the Defeasance Resolution: Resolution authorizing the transfer of funds, the establishment of an escrow account with respect of and the defeasance of certain of the general obligation refunding bonds.
