

RESOLUTION in support of diversity training for school resource officer (SRO)

September 2, 2020

Joint School District Number 2, Village of Marshall, Towns of Cottage Grove, Deerfield, Medina, Sun Prairie and York, Dane County, Wisconsin

Whereas, the Marshall Joint School District is developing plans to improve equity and social justice in the district; and

Whereas, training in cultural awareness and active anti-racism practices are anticipated; and

Whereas, the District has found value in having an SRO, and has renewed that contract for the 2020-21 school year; and

Whereas, we acknowledge community concerns on racial justice, and recognize that SROs are parts of that concern for some members of our school community; and

Whereas, our SROs have voiced a desire to be regarded as part of the school staff;

Therefore, be it resolved that SROs be included in the training programs offered to, or required of, other district staff, with training at district expense and on the SRO's district time; and

Be it further resolved that the District will actively engage with the Marshall Police Department to better understand what content is already part of the existing SRO training syllabus; and

Be it further resolved that the SRO may serve as a vanguard in this process, potentially receiving training after pre-evaluation by administration but before it is rolled out to the entirety of the District staff.

Members of the School Board for the Marshall Public Schools unanimously voted (7-0) to approve this resolution the 2nd day of September, 2020.
